GENERAL TERMS AND CONDITIONS FOR THE USE OF THE CLUB ZIGZAG (translation of French language contract)

These conditions are designed to define the conditions of access to and use of facilities made available to members and visitors of the club ZIGZAG.

1) SPIRIT OF THE CLUB ZIGZAG

The general spirit that presides in implementing the terms and conditions of ZIGZAG club aims to administer, manage and develop a playground for children aged 6 months to 11 years equipped with facilities that conform to the games safety standards. The philosophy of ZIGZAG CLUB:

A games area does not constitute:
-- Day care,
-- A substitute for parents,
-- School for the holidays,
-- A place where anything goes,
-- A place where the child is king.

A games area is a place:
-- of welfare,
-- for groups of children from different backgrounds and different ages,
-- of expression and fulfillment,
-- where children and adults have rights and responsibilities
-- where the child is the knight, princess or the hero of her dreams just for a few hours, in accordance with everyone else's dreams and expectations.

2) ACCESS TO THE ZIGZAG SPACE

Only members of ZIGZAG club, who have paid their membership fees per family and their entry fee have authorized access to the playground. Access to the restaurant is also open to non-members.

Each member and visitor unconditionally and irrevocably accepts the terms of these general conditions.

Families visiting for the first time receive a visitor's card.

Before leaving, they pay for their drinks, food and game access, and render the card at the reception.

3) SOLE RESPONSIBILITY OF PARENTS

Each member with a child/children assumes the powers of custody and supervision on the said children in their charge. Under no circumstances, can anyone be allowed any transfer of custody or supervision, for any reason.

4) INVOLVEMENT OF THE ZIGZAG CLUB'S RESPONSIBILITY

In the event of any physical injury or material damage caused to others, each member consents that they will not hold ZigZag sarl, its representatives, and staff, in anyway responsible for any possible legal action taken against him.

5) USE OF THE PREMISES OF RESTORATION

Access to the café/restaurant) is free to anyone who wishes to consume beverages and other snacks or meals provided by the catering service. With the exception of baby food, it is forbidden to eat your own food. No picnics!

Those with children must ensure respect for the enjoyment of others in the café. Children are prohibited from running in this area.

**6) USE OF PLAY AREA**

- A) Observe strict compliance with the age limit

Any member wishing to enter the play areas should ensure strict adherence to the age limits for each area. Children aged over 3 years are prohibited from entering the area for children under 3 years. Conversely, children aged under the age of 3 should not play in the area for those aged over 3 years, unless they are accompanied by a responsible adult.

- B) Use equipment appropriately

Each member formally undertakes to respect and to ensure respect by their children, instructions for use and safety of the play area.

Notably, it is prohibited to:

-- Carry or bring accessories to the play area (for example: jewelry, belts...). Wearing glasses views is also discouraged. However, it is up to each adult to decide on the needs of the child in wearing glasses.

-- Go up the slides in the opposite direction,

-- Climb on the outer nets,

-- Move accessories or components of the play area,

-- Block the passage, or access to areas, of other children.

Adults accompanying children can accompany their children to all playing areas, with the exception of the inflatable mats (bouncy castle).

This list is not exhaustive. It is understood that the bans cover all the attitudes that the rules of safety and prohibit use.

- C) Hygiene Measures

Hygiene measures should also be strictly observed.

These include:

-- Children and adults who enter the playgrounds must remove their shoes and must wear socks.

Shelves for the storage of shoes can be found at the entrance to the games area on the ground floor, through the restaurant, and also on the first floor.

-- Anyone crossing the playground to go to the toilet must wear the shoe protectors provided for this purpose.

-- It is strictly forbidden to drink or eat in the play area, even in the one for children under 3 years.

This list is not exhaustive. It is understood that the bans cover all the attitudes that the hygiene rules prohibit.

**7) WITH THIRD PARTY MEMBER**

Each member who brings a third party, whether adults or children, and who is unidentified by the membership contract which binds the club ZIGZAG, formally agrees to pay the cost of access to the play area.

These third parties are also bound by the rules and regulations of the Club Zig Zag as defined in paragraph 5) and 6) of these general conditions.

The penalties set out in paragraph 8) of these terms and conditions will also be applied in cases of non-compliance by the third parties, safety standards, usage and hygiene conform to the play and common spaces.

**8) LACK OF RESPECT FOR SAFETY AND APPROPRIATE USE OF THE PLAY AREA AND COMMON AREAS**

Each member or child who does not conform to access, security, safety, hygiene and play area use regulations will be immediately and temporarily excluded from the club, without refund of the entry price.

The duration of this exclusion will depend on the seriousness of the irregularities discovered.

This exclusion could lead to a final eviction of CLUB ZIGZAG if non-compliance with the rules laid down in points 4) and 5) results in harm to either persons or property.

In this instance, the member of ZIGZAG CLUB will have no right to reimbursement of the membership fee and entrance fee and / or contributions.

**9) ORGANIZATION OF BIRTHDAY PARTY AND OTHER FESTIVITIES**

Organizers must provide, prior to the date and time chosen and at least 3 days in advance, the number of those invited. The guests will be allowed entry on the chosen date and specific time, upon receipt of a ZIGZAG CLUB invitation. Participants will be directed to the party room.

**10) THEFT**

The club ZIGZAG accepts no liability in case of theft.

**11) VIDEO RECORDING SURVEILLANCE**

The club ZIGZAG informs its members that video surveillance is conducted at the entrance of its premises and in the play area.

Every person with access to the club ZIGZAG is deemed to have given his express consent to be filmed.

Those terms and conditions are to be interpreted with Luxemburgish Law. Any contestation as to its interpretation and/or execution will be brought to Luxemburgish jurisdiction.
